BUSINESS SPONSORSHIP AGREEMENT

(Terms and Conditions)

This **BUSINESS SPONSORSHIP AGREEMENT** is made and executed by and between Major Flavor LLC dba Madd Rhyma Productions hereinafter referred to as “**BROADCASTER**” and _____ hereinafter referred to as “**SPONSOR or CLIENT**”.

1. INVESTMENT OF SPONSOR

a) Sponsor agrees to engage Madd Rhyma Productions for contracted promotional services using the internet radio and/ or multimedia platforms associated with **illadelphiaradio.com** as described and elected herein.

2. AGREEMENTS

a) BROADCASTER agrees to promote business marketing information and images via the internet radio and/ or multimedia platforms associated with **illadelphiaradio.com** for a specified period as mutually agreed.

b) SPONSOR agrees to provide all necessary digital assets and images pertaining to the nature of its contracted services requested. By federal, state, and local guidelines, the Broadcaster is not permitted to inform the Sponsor at what time their station IDs will be played.

3. PAYMENTS & CANCELLATIONS

- (1) The Client agrees to pay for all services upon receipt of their initial invoice, and on the 1st of the Month for each month of contracted services thereafter.
- (2) The initial invoice will outline the full scope of services requested by the Client, and contain billing for the first and last month of contracted services.
- (3) The Client may terminate the contract by giving 30 days' written notice to the Broadcaster. The Client and Broadcaster mutually agree that, following the request for termination, the Broadcaster will carryout all services through the last day of the contracted month.
- (4) The Broadcaster may terminate the contract if the Client's initial invoice is not paid within five (5) business days or if the Client's Monthly invoice is not paid by the 5th day of the month, and will notify the Client in writing that their services will end on the last day of the contracted month. The Client and Broadcaster mutually agree that, following the notice of termination, the Broadcaster will carryout all services through the last day of the contracted month.
- (5) Payment of invoice(s) constitutes acceptance of terms, and all payments are non-refundable.

The Broadcaster shall not be liable (directly or indirectly) for any damages, losses, costs or expenses suffered by the Client as a result of substitution, interruption, postponement, inability or failure to broadcast any advertising by reason of (a) technical or mechanical difficulties, public emergency or necessity, legal restriction, strike or labor action, terrorism, (b) failure of any third party transmission, (c) regulations, directions, orders, or other requirements of any federal, provincial, municipal authority or any applicable regulatory bodies, including the Radio-television and Telecommunications.

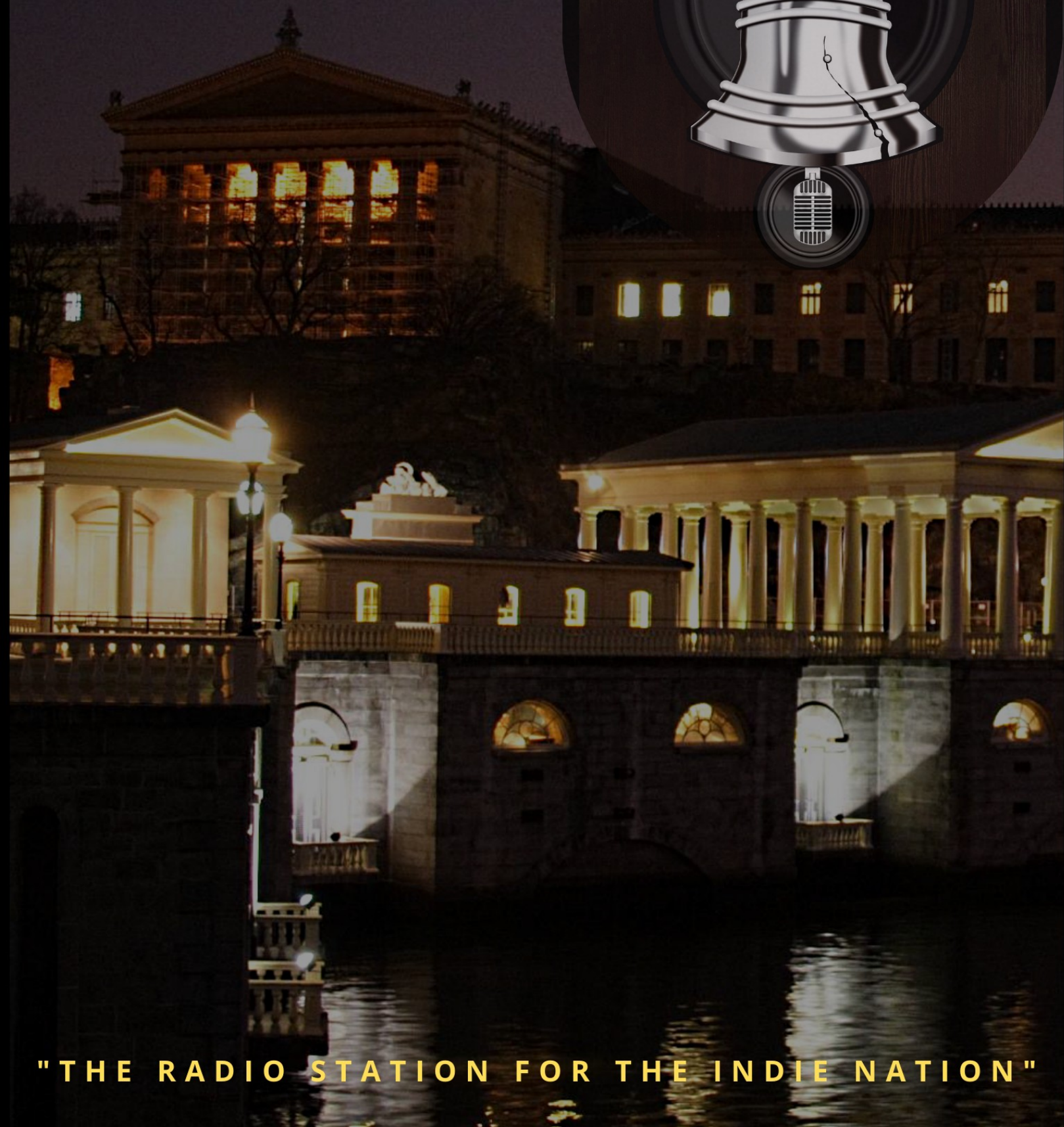
